- Implementing and managing Azure DNS and network security groups NSGs.

Unit 2:

Azure Identity and Access Management:

- Configuring Azure Active Directory AD and managing users and groups.
- Implementing and managing role-based access control RBAC.
- Configuring Multi-Factor Authentication MFA for enhanced security.
- Managing and integrating on-premises Active Directory with Azure AD.
- Implementing and managing Azure AD Connect for hybrid identities.

Azure Storage Solutions:

- Overview of Azure Storage accounts and services.
- Implementing and managing Blob storage, File storage, and Disk storage.
- Configuring Azure Storage replication and redundancy options.

- Securing and monitoring Azure Storage with access controls and logging.

- Implementing network security solutions, including Azure Firewall and DDoS protection.
